The Invitations to Bid (ITB) follows the General Procurement Notice that appeared in dgMarket on February 1, 2017 and UNDB online on February 3, 2017 and on the MCA Entity website [http://mca-indonesia.go.id/pengadaan/general-procurement-notice/general-procurement-notice-period-january\\_march\\_2017-1054](http://mca-indonesia.go.id/pengadaan/general-procurement-notice/general-procurement-notice-period-january_march_2017-1054), on February 1, 2017, and local newspaper Kompas on February 3, 2017.

This ITB is open to all eligible entities or persons (“Bidders”) who wish to respond. Bidders may only associate with each other in the form of a joint venture or in a sub-contractor agreement to complement their respective areas of expertise to enhance their capacity to successfully carry out the service and so long as any association is otherwise formed in accordance with the terms of the ITB.

2. A Bidder will be selected under the Competitive Bidding procurement method, the evaluation procedure for which is described in sections of the ITB in accordance with “MCC Program Procurement Guidelines” which are provided on the MCC website [www.mcc.gov](http://www.mcc.gov) .

The Millennium Challenge Corporation (“MCC”) and the Government of the Republic of Indonesia (the “Government”) have entered into a Compact for Millennium Challenge Account (“MCA”) assistance to help facilitate poverty reduction through economic growth in Indonesia (the “Compact”) in the amount of US\$ 600,000,000 (“MCC Funding”). The Government, acting through the Millennium Challenge Account - Indonesia (“MCA-Indonesia”), intends to apply a portion of the funds to eligible payments under the contract for which this Invitation to Bid is issued. Payment by MCC will be made only at the request of MCA-Indonesia and upon approval by MCC, and will be subject, in all respects, to the terms and conditions of the Compact, including restrictions on the use of MCC Funding and conditions to the disbursements.

**The activities of the Community-based Health and Nutrition to Reduce Stunting Project are:**

**Community Projects Activity:** The financing of community block grants and participatory technical assistance to communities

**Supply-Side Interventions Activity:** The financing of training to Service Providers, sanitation and hygiene activities, provision of multiple micronutrient packets, material to measure children’s height, and other incentives, as well as private sector interventions:

- Training and Advocacy Sub-Activity
- Private Sector Response Sub-Activity

**Communications, Project Management and Evaluation Activity:** The financing of communications outreach, project management and monitoring and evaluation.

The services under this procurement fall under the Community-based Health and Nutrition to Reduce Stunting Project, Supply–Side Interventions Activity. MCA-Indonesia during the period of the Compact (6 remaining months) will require the service of printing, packing and delivery of training materials for the Community-based Health and Nutrition to Reduce Stunting Project.

The objective of MCA-Indonesia, through this Invitation to Bid, is to request prices for the service of “Re-design, Printing, Packaging and Distribution of New Maternal Infant and Young Child Feeding Modules and Infant and Young Child Feeding Modules Promotion Material” and to hire a company under a Purchase Order for Printing Service.
