4. The Millennium Challenge Corporation (“MCC”) and the Government of the Republic of Indonesia (the “Government”) have entered into a Compact for Millennium Challenge Account (“MCA”) assistance to help facilitate poverty reduction through economic

growth in Indonesia (the “Compact”) in the amount of US\$ 600,000,000 (“MCC Funding”). The Government, acting through the Millennium Challenge Account - Indonesia (“MCA-Indonesia”), intends to apply a portion of the funds to eligible payments under the contract for which this ITQ is issued. Payment by MCC will be made only at the request of MCA-Indonesia and upon approval by MCC and will be subject, in all respects, to the terms and conditions of the Compact, including restrictions on the use of MCC Funding and conditions to the disbursements.

The Compact Program includes five Components: a) the Green Prosperity Project (“GP”), b) the Community-based Health and Nutrition to Reduce Stunting Project, c) the Procurement Modernization Project, d) the Monitoring and Evaluation Component and e) the Program Administration and Control.

The Provision under this Procurement falls under the Procurement Modernization Project Component.
